REGULATIONS REGARDING THE SALE OR DISPLAY OF FIREARMS. AMUNITION AND/OR ANY OTHER DANEROUS WEAPONS

Wisconsin Administrative Code section 2.14 outlines the definition and requirements pertaining to the possession and sale of firearms, ammunition and/or other dangerous weapons at Wisconsin State Fair Park. The administrative code cites the written approval from the WSFP Chief of Police for any such exemptions to the code. As such, with signature of the Chief of Police on the bottom of this completed and approved form, the vendor listed on the first page of this form may display and sell the items listed on this form under the following conditions:

- Firearms must be unloaded. No magazines may be inserted into firearms.
- No firearms, ammunition and/or other dangerous weapons may be left unsecured and in sight of the public without the presence of an authorized employee of the vendor.
- All firearms, ammunition and/or other dangerous weapons must be locked up or removed from the premises each night.
- Edged weapons must be secured in cases and out of reach of patrons. Authorized employees of the vendor may
 allow patrons to handle one item at a time upon request. Each item handled must be returned to its secure case
 once the patron is done with it.
- Vendor may engage in accepting payment and placing orders for off-site or mail delivery of firearms and/or ammunition but may not engage in point of service retail sales on site for same.
- Wisconsin State Fair Park reserves the right to amend or change these regulations at any time.
